Plaintiffs' Notice of Request for Entry of Deadlines, having been presented to the Court, the Court having been fully apprised on the premises, finds that good cause has been shown to enter the following deadlines.

Good cause appearing, **IT IS HEREBY ORDERED:**

1. The current deadlines are entered as follows:

a. Final Approval Motion Deadline: **Friday, June 10, 2022** [or a date to be set by the Court no earlier than 14 days following entry of the Scheduling Order];

b. Objection to Final Approval Motion Deadline: **Monday, June 27, 2022** [or a date to be set by the Court no earlier than 30 days following entry of the Scheduling Order];

c. Reply in support of Final Approval Motion Deadline: **Monday, July 11, 2022** [or a date to be set by the Court no earlier than 37 days following entry of the Scheduling Order];

d. Reply in Support of Application for Attorneys' Fees, Expenses, and Service Award Deadline: **Monday, July 11, 2022** [or a date to be set by the Court no earlier than 37 days following entry of the Scheduling Order];

and

e. Final Approval Hearing: **Monday, August 8, 2022** [a date to be set by the Court no earlier than 51 days following entry of the Scheduling Order], at **10:00 a.m. in Aha Kaulike**.
