REGARDING NOTICE TO
THE CLASS

- I, Dana Boub, pursuant to 28 U.S.C. §1746, hereby confirm that I am over 18 years of age and competent to make the following Declaration and state as follows:
- 1. I am a project manager for RG/2 Claims Administration LLC ("RG/2 Claims"), whose address is 30 South 17th Street, Philadelphia, PA 19103. I have personal knowledge of the matters set forth herein, and if called upon to do so, could testify competently to them.
- 2. RG/2 Claims is a full-service class action settlement administrator offering notice, claims processing, allocation, distribution, tax reporting, and class action settlement consulting services. RG/2 Claims' experience includes the provision of notice and administration services for settlements arising from antitrust, consumer fraud, civil rights, employment, negligent disclosure, and securities fraud allegations. Since 2000, RG/2 Claims has administered and distributed in excess of \$1.2 billion in class action settlement proceeds.
- 3. On August 13, 2021, the Court appointed RG/2 Claims as the Settlement Administrator¹ for the Settlement. ECF No. 411, at 64. RG/2 Claims was retained by the Parties to, among other tasks: (a) prepare, print, and mail 169 notices to all Class Members identified by Defendants; (b) track the requests for exclusion and objections; (c) prepare weekly activity reports for Counsel; (d) handle

inquiries from Class Members; (e) re-mail notices; (f) skip-trace undeliverable addresses; (g) calculate and issue distribution checks to Class Members; (h) maintain the Settlement Website; and (i) conduct such other tasks as the Parties mutually agree or the Court orders RG/2 Claims to perform. RG/2 Claims will continue to perform these duties in effectuating the Settlement Agreement hereafter.

- 4. Subsequent to mailing the various Mail Notices, a total of 27 Mail Notices were returned by the United States Postal Service ("USPS") as undeliverable. RG/2 performed multiple skip traces to search for updated addresses for the Class Members and was able to re-mail 26 of the Mail Notices to updated addresses. Of the 26 Mail Notices that were re-mailed, two were returned to RG/2 Claims by USPS. Newly updated addresses for these two undeliverable Mail Notices were located and RG/2 re-mailed Mail Notices to these new updated addresses. To date, only one Mail Notice remains undeliverable. As such, 99.4% of the Settlement Class received direct mail notice and thus, the threshold for the optional Publication Notice was not triggered.
- 5. The Mailed Notice informed Class Members of their right under the Settlement to request exclusion from the Settlement, provided the request is postmarked no later than December 6, 2021. To date, RG/2 Claims has received Requests for Exclusion from the Settlement from Class Members representing 32 properties. A true and correct copy of a list of the Class Members representing 32

properties who opted out of the Settlement and the Class Members' Requests for Exclusion is attached as Exhibit A.

- 6. To date, RG/2 Claims has received two additional Requests for Exclusion from the Settlement for individuals who are not included in the Class Member data provided to RG/2 Claims by Class Counsel, and thus, it is presumed that these are invalid opt outs. A true and correct copy of the list of invalid opt outs and their Requests for Exclusion is attached as Exhibit B.
- The Mail Notice also informed Class Members of their right under the 7. Settlement to object to the Settlement or Class Counsel's request for attorneys' fees, provided the objection is postmarked no later than December 6, 2021. The deadline for Class Members to object to Class Counsel's request for attorneys' fees has passed. After the Court issued an extension of the deadline for Class Members to object to final approval of the Settlement to January 28, 2022, RG/2 promptly posted the revised deadline to the Settlement Website. On January 21, 2022, the Court vacated the deadline for Class Members to object to final approval of the Settlement. On May 25, 2022, the Court set the deadline for Class Members to object to final approval of the Settlement to June 27, 2022. RG/2 promptly posted the revised deadline to the Settlement Website. To date, RG/2 Claims has not received or has been advised of any objections to the Settlement or Class Counsel's request for attorneys' fees.
